Excellent pre-emergent weed control without root pruning

Ronstar® is a selective granular pre-emergent herbicide that can be used on a range of turf species.

It does not affect root systems and therefore offers a flexible approach to effective, economic weed control.

Key features:

- ✓ Pre-emergent herbicide that kills weeds prior to emergence from soil.
- ✓ Granular formulation which is easy to handle and apply.
- ✓ Season long weed control – controls germinating weeds for up to 10 weeks.
- ✓ Retains activity over a wide range of soil types, organic matter content and soil pH.
- ✓ Does not leach or move significantly in the soil.
- ✓ Low hazard to the user, public and birds.
- ✓ Is not taken up by roots; does not prune the roots of turfgrass plants.

Application rates and delivery

- Apply using ground based application equipment at the rates listed in the table below.
- On established turf Ronstar should be applied in autumn for winter weeds and spring for summer weeds.
- Uniform application is essential for satisfactory weed control. Ensure that the granular applicator is properly calibrated.
- Turf area should be free from leaves and other debris to ensure granules reach the soil surface.
- Oscillating spout and rotary type fertiliser spreaders are recommended for large areas. Irrigation should be applied after application to create the herbicide barrier in the soil.

General comments on application

- Use Ronstar on turf farms to treat freshly cut areas. This establishes a herbicide barrier that will prevent weed infestation while the turf is re-establishing.
- Ronstar is ideal for use on sports fields to treat goal mouths and worn areas. These areas are susceptible to infestation by annual grass and broad leaf weeds.
- Application will prevent weed establishment and speed up turf recovery.
- Construction of new turf areas involves creation of conditions that are ideal for establishment of weeds.
